

Dear SDSEO Member:

First off, the best news: We added two new members this past week!

Now to the Legislature: Twelve days of legislative session have now passed. There are 26 more legislative days to go, counting Veto Day.

Last update I had just 4 bills on your list, with maybe 20 others of some relation on my own list. Well, that ended the last week, as my personal SDSEO list is now 94 bills, and that doesn't include vehicle bills (bills with just a subject and a sentence intended to be amended later). And that doesn't count budget hearings and budget documents, which are a whole other animal. I've included the whole thing this update.

Overall, though, your priority bills are the Retirement System bills, including a new bill added outside of the SDRS that seeks to add 911 operators into SDRS. Ordinarily I'd say the bill had no chance, because it didn't go through "the process," but the SDRS Board of Trustees has a bill to add EMS personnel to Class B public safety retirement, and anyone who's been around the SDSEO for the last 10 years has seen plenty of employee groups who really should be Class B, including the entirety of Yankton HSC and Redfield staff and all DOC employees, not get so much as a sniff at Class B public safety retirement. Just a couple years ago the rationale for not adding employees to Class B public safety was anyone who didn't go thru highway patrol-style training wasn't a fit for Class B public safety. So who's to say the legislators won't go ahead and put another group in this one time? And then maybe we can get all those employees who should be Class B into Class B.

And food tax bills <u>HB1095</u> and <u>HB1096</u> dropped. Those are important to watch. And there's a gross receipts and use tax <u>bill</u>. And a vehicle <u>bill</u>. And the governor's Family Leave <u>bill</u>. Here's <u>one</u> that seeks to alter meal reimbursement and household moving allowance procedure. There's some good stuff in there but I haven't quite figured out all of it. It probably should have been two or three bills.

But <u>HERE</u> is a bill built right upon the slippery slope of the law the Legislature helped make to give themselves and nobody else automatic raises every year. In it lies a special mileage rate just for legislators. It strikes "state rates established by the Board of Finance" and inserts "business standard mileage rate authorized by the IRS." What's that rate? In 2022 it was 62.5-cents per mile. Our state rate was 42-cents per mile until this interim, when the Legislature wanted to give itself alone an immediate mileage increase, but the law, which would be changed with this bill, didn't allow that. So the S.D. Board of Finance dutifully went to work raising the mileage rate for everyone in the state to 51-cents per mile. Make no mistake, if the Legislature didn't have to give everyone a higher rate, it wouldn't have.

How would you like to be paid at 100% of market, automatically every year, instead of shrinking budgets under the horrible term "right sizing"? That's what this proposal would do for "methodology" for

"community-based providers." Those providers are primarily really large businesses, by the way, not employees or patients.

I couldn't help but notice that every department outside of the Executive Branch has asked for more than 5% because 5% isn't even the cost of living, which is at least 7%. The Board of Technical Education asked for 7%. The Unified Judicial System asked for an "agency specific salary adjustment." The Legislature and its various employees are booked for 6.0-6.5%. That's not bad stuff for the employees, some of whom are you, excellent upstanding SDSEO members, and it's not bad stuff for those of you who aren't in those departments. I only mention it because we want fairness and equity for all state government employees.

I also couldn't help but notice that while the state departments mostly requested a 2.4% increase for "discretionary provider inflation" for contracted healthcare and other services providers, Governor Noem recommends to give those providers a 5% increase. There's been some Appropriator talk that maybe the Legislature will go ahead and try to give some others of the Big Three more than you state government employees receive. That news came from a Yankton legislative crackerbarrel.

I want to encourage all of you to come to the Legislature and testify on your behalf at the Feb. 8 state employee compensation budget hearing. It's set to run from 9:45 a.m-10:45 a.m. Not to air grievances or point blame or go out of your lane, because I tell you what, that's when folks get in a bind, but to say, "Honorable representatives and senators, I love serving the state. It's not just a pass-through job. I'm not here to pass through the state as a contracted gun for hire, seeking greener pastures every couple months. It is my career. But I need your support. I don't get to see you everyday in the halls and meeting rooms, because my job has me elsewhere, so I'm here today to ask you, please help. It's no small feat to come here today. I'm sure you are aware. Thank you. If you have any questions about me or my family and what we need, not my specific job or department, because I can't answer those, please ask. Thank you."

The winds blow every which way during a legislative session, let's blow in some good stuff.

Keep the faith and keep up the fight.

All the SDSEO's funding comes from membership; outfits like this receive zero state or federal dollars or incentives or tax breaks. While so much of the non-profit universe is focused on deserving 501c(3) charities that were created to seek donations and then give the funds away to hard-pressed folks either in the form of cash or in the form of services, professional and labor non-profits such as the SDSEO are important too. Non-profit organizations like the SDSEO exist to help create and maintain healthy careers and service, hopefully keeping charities in the business of providing aid to the hardest pressed. That's why charities have tax-free donation and deduction status and organizations like the SDSEO do not.

Make sure to spread the word about the SDSEO and encourage membership. Membership is \$10/month. You're likely going to go out with co-workers on lunch or after work: Maybe offer to pay for their lunch that one time (you're probably going to anyway at some point, since you're a South Dakotan) and encourage them to join the SDSEO, which likely costs less than 1 work lunch a month.
